PATENT ASSIGNMENT AGREEMENT

WHEREAS, E. L. I. O. - DESENVOLVIMENTO TÉCNICO E CIENTÍFICO DE EQUIPAMENTOS ESPECIAIS LDA, a corporation having a principal place of business at Matosinhos, Portugal ("Assignor"), is the owner of the entire right, title and interest under the patent properties listed in Exhibit A ("Assigned Patent Properties"); and

WHEREAS, ELJO TECNOLOGIA SERVIÇOS E PARTICIPAÇÕES LTDA., a Brazilian corporation having a principal place of business at Rua Itaprya, 202, Conj. 100, São Paulo - SP, Brazil 01322-000 ("Assignee"), is desirous of acquiring the Assigned Patent Properties and any rights in the Assigned Patent Properties.

NOW, THEREFORE, in consideration of good and valuable consideration acknowledged by Assignor to have been received in full from Assignee:

1. Effective March 29, 2022, Assignor does hereby sell, assign, transfer and convey unto Assignee, all of their right, title and interest together with the benefits and privileges in and to said inventions and discoveries, said Application for Letters Patent, the Assigned Patent Property or similar forms of protection of the United States of America, and all other applications for Letters Patent on said inventions and discoveries in whatsoever countries, including all divisional, renewal, substitute, continuation and convention applications based in whole or in part upon said inventions or discoveries, or upon said application, and any and all Letters Patent, reissues and extensions of Letters Patent or similar forms of protection granted for said inventions and discoveries or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said discoveries, said applications and said Letters Patent, including all rights to said inventions, discoveries and said Patents and applications as fully and entirely as the same would have been held and enjoyed by me if this Agreement had not been made, including all claims for damages and/or injunction by reason of past and present infringement and including the collection and retention of such damages for the use and enjoyment of Assignee and its successors and assigns;

2. Assignor authorizes Assignee to file patent applications in any or all countries or groups of countries on any or all of said inventions and discoveries in our name or in the name of Assignee or otherwise as Assignee may deem advisable, under the International Convention or any other relevant convention or treaty or otherwise;

3. Authorize and request the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments to issue or transfer all said Letters Patent to Assignee, as assignee of the entire right, title and interest therein, or otherwise as Assignee may direct;

4. Warrant that Assignor has not knowingly conveyed to others any rights in said inventions, discoveries, applications or patents or any license to use the same or to make, use or sell anything embodying or utilizing any of said inventions or discoveries; and that I have good right to assign the same to Assignee without encumbrance;

5. Assignor hereby covenants and agrees to cooperate with Assignee to enable Assignee to enjoy to the fullest extent the right, title and interest herein conveyed in the United States. Such reasonable cooperation by Assignor shall include production of pertinent facts and documents, giving of testimony, execution of petitions, oaths, specifications, declarations or other papers, and other assistance all to the extent deemed reasonably necessary or desirable by Assignee and agreed to by Assignor which agreement shall not be unreasonably withheld, (a) for perfecting in Assignee the right, title and interest herein conveyed; (b) for filing and prosecuting substantive, divisional, continuing or additional applications covering the Assigned Patent Property; (c) for filing and prosecuting applications for reissuance of any of the Assigned Patent Property; (d) for interference or other priority proceedings involving the Assigned Patent Properties; and (e) for legal proceedings involving the Assigned Patent Property for infringement actions and court actions; provided, however, that the expense incurred by Assignor in providing such cooperation shall be paid for by Assignee.

6. The terms and covenants of this assignment shall inure to the benefit of Assignee, its successors and assigns, and shall be binding upon Assignor and its assigns.
