to this assignment. We do hereby authorize said ASSIGNEE to apply in our name or in their own name (in a manner to be agreed upon by said ASSIGNEE) or their designee, for patents and like rights of exclusion on or for said inventions in all countries, claiming (if said ASSIGNEE so desires) the priority of the filing date of said application under the provisions of said Convention, Treaty or any such other Convention or Treaty. 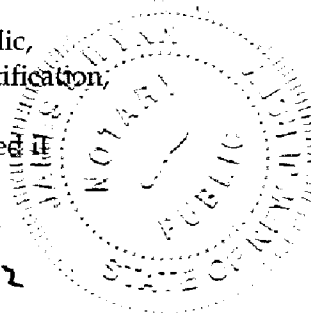

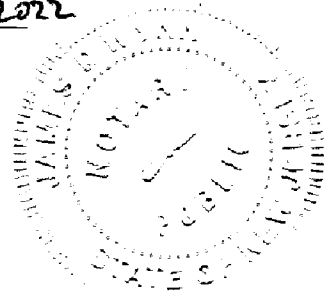
