AMENDED AND RESTATED PATENT ASSIGNMENT

This AMENDED AND RESTATED ASSIGNMENT ("Amended and Restated Assignment"), effective as of April 1, 2022, is made and entered into by and among the following (each a "Party" and collectively, the "Parties"):

(1) Scientific Games, LLC (formerly known as Scientific Games, Inc.), a corporation organized and existing under the laws of Delaware ("Assignee");

(2) Scientific Games International, Inc., a corporation organized and existing under the laws of Delaware ("Assignor").

Capitalized terms used herein but not otherwise defined herein shall have the meanings set forth in the EPA (as defined below).

WHEREAS, Scientific Games Corporation, a Nevada corporation ("SG CORP") and BCP Acquisitions LLC, a Delaware limited liability company ("Buyer"), have entered into a certain Equity Purchase Agreement, dated as of October 27, 2021 (the "EPA"), pursuant to which Buyer or certain of its Affiliates agreed to purchase from SG CORP and its Affiliates, and SG CORP and its Affiliates agreed to sell to Buyer or such Affiliates, the Transferred Equity Interests and other assets, on the terms and subject to the conditions set forth in in the EPA (the "Acquisition");

WHEREAS, Scientific Games International, Inc. (Assignor) is an Affiliate of SG CORP;

WHEREAS, Scientific Games, LLC (Assignee) will be transferred to Buyer in connection with the Acquisition;

WHEREAS, in connection with the Acquisition, Assignor and Assignee have entered into an initial assignment (the "Initial Assignment") dated October 26, 2021 and recorded at the United States Patent and Trademark Office at Reel/Frame Numbers: 057970/0859, 057970/0894, 057970/0948, 057970/0976, 057971/0060, 057971/0076, 057971/0088, 057971/0107, 057971/0136, 057971/0124, 057971/0616 and 057971/0640;

WHEREAS, (i) the Initial Assignment inadvertently referred to the date of assignment "*as of the respective filing dates listed, above,*" (ii) the Initial Assignment omitted certain patent numbers and issue dates for certain of the Assigned Patents and Patent Applications, (iii) the Initial Assignment erroneously included patent number 7,874,902, (iv) the Initial Assignment lacked certain provisions related to further assurances, governing law, and general provisions, and (v) the Assignee has since undergone a change of name and is now known as Scientific Games, LLC, and Assignor and Assignee now wish to amend and restate the Initial Assignment as set forth above and otherwise restate the Initial Assignment in its entirety as set forth herein;

WHEREAS, Assignor and Assignee desire to confirm validity of the Initial Assignment and confirm that the effective assignment date of the Initial Assignment was its execution date of October 26, 2021;

WHEREAS, in connection with the Acquisition, SG CORP, on behalf of itself and its Affiliates (including Assignor), has agreed to sell, transfer and assign to Assignee, and Assignee has agreed to acquire, all of their right, title, and interest in and to certain Assigned Patents and Patent Applications (as defined below), including the US and foreign issued patents and pending patent applications identified in Schedule A to the Initial Assignment and identified in Schedule A to this Amended and Restated Assignment.

NOW, THEREFORE, for good and valuable consideration, including the premises and covenants set forth in the EPA, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Assignment. ASSIGNOR does hereby sell, assign, and transfer, and hereby set over unto ASSIGNEE, its successors, assigns and legal representatives, as of October 26, 2021, *nunc pro tunc*, (i) the full and exclusive right, title and interest in the Patents, all related applications thereto including, but not limited to, any and all patents, patent applications or provisional applications that are referenced by the above to provide priority and those that receive priority therefrom, any present or future continuations, continuations in part, divisionals, reexaminations, reissues, and foreign counterparts thereof and any patent or patent application that receives priority therefrom (all additionally included hereinafter within the "Patents"); (ii) the right to make application for patent for said inventions disclosed in the Patents in the United States and any and all foreign countries; (iii) the right to claim priority as to the filing date under United States law and the Patent Cooperation Treaty on the basis of the aforesaid Patents; and (iv) any claims for damages and all remedies arising out of any violation of the rights assigned hereby that ASSIGNOR may have that may have accrued prior to the date of assignment to ASSIGNEE, or may accrue hereafter, anywhere in the world, including, but not limited to, the right to sue for, collect, and retain damages for past infringements of the Patents in the United States, or for past infringements of any patent claiming priority to the Patents which has been or may be granted in any country anywhere in the world, together, in each case, with the right to fully and entirely stand in the place of the ASSIGNOR in all matters related to any of the foregoing; and ASSIGNOR hereby authorizes and requests the Commissioner of Patents to issue all letters patents issuing therefrom to ASSIGNEE, for its interest as ASSIGNEE, its successors, assigns and legal representatives.
2. Further Assurances. Assignor shall, upon reasonable request of Assignee and at Assignee's expense, provide to Assignee, Assignee's successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the timely execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments or other documentation) and take such other reasonable actions as may be necessary or desirable to record, memorialize or perfect Assignee's right, title and interest in, to and under the Assigned Patents.
3. Governing Law. This Confirmation and Assignment, and all matters, claims, controversies, disputes, suits, actions or proceedings arising out of or relating to this Confirmation and Assignment and the negotiation, execution or performance of this Confirmation and Assignment or any of the transactions contemplated hereby, including


all rights of the Parties (whether sounding in contract, tort, common or statutory law, equity or otherwise) in connection therewith shall be interpreted, construed and governed by and enforced pursuant to the laws of the State of Nevada, without regard to the conflicts of law rules of such state.

4. General Provisions. This Confirmation and Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Confirmation and Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Confirmation and Assignment. This Confirmation and Assignment is entered into pursuant to the EPA. To the extent of any conflict between this Confirmation and Assignment and the EPA, the EPA will govern. This Confirmation and Assignment is binding upon and inures to the benefit of the parties hereto and their respective successors and assigns.


