4. 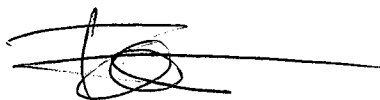

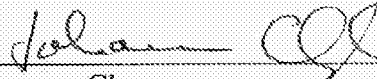
