CONFIRMATION OF PATENT ASSIGNMENT AND POWER OF ATTORNEY

1. **U. WINDMÖLLER CONSULTING GMBH AND CO KG**, a company incorporated and existing under the laws of Germany with its registered office at Ottenheide 60, 33758 Schloss Holte-Stukenbrock, Germany (hereinafter referred to as "**UWC**" or "**Transferor**");
- and
2. **I4F LICENSING NV**, a company duly incorporated and organized under the laws of Belgium, having its registered office at Oude Watertorenstraat 25, 3930 Hamont-Achel, Belgium (hereinafter referred to as "**I4F**");
3. **FLOORING INDUSTRIES LIMITED SARL**, having its registered office at Ooigemstraat 3, B-8710 Wielsbeke, Belgium (hereinafter referred to as "**FI**");
4. **VÄLINGE INNOVATION AB**, having its registered office at Prästavägen 513, 263 65 Viken, Sweden (hereinafter referred to as "**Välinge**", and together with I4F and FI as the "**Transferee**")

Transferor and Transferee also referred to individually as "Party" and jointly as "Parties"

PATENT ASSIGNMENT

On April 1st, 2021 (hereinafter the "**Effective Date**"), Transferor assigned all of its rights, title and interest in the patent and patent applications listed in ANNEX A ("**Patents**") to I4F. I4F declares to have accepted the assignment and upon obtaining ownership of the Patents to have assigned equal parts of its ownership rights in the Patents to FI and Välinge which in turn declare to have accepted the assignment.

As a result of the assignment of the Patents I4F, FI and Välinge now jointly own all rights title and interest in the Patents and wish to be registered as co-applicant/co-holders/co-assignees of the Patents in the various relevant patent registers of the applicable patent offices.

To effect the recordal, the Parties herewith grant **Bastiaan Wilhelmus Herman (Bas) Langenhuijsen of Patentwerk B.V., Julianaplein 4, 5211 BC 's-Hertogenbosch**, the Netherlands, a power of attorney to have the assignment and I4F, FI and Välinge registered and recorded as co-applicants/co-owner/co-assignees of the Patents instead of and replacing UWC in all the relevant patent registers and to file requests for such recordal with all the applicable patent offices. This power of attorney is valid until five (5) years after the signing date of this agreement and includes the right for Bas Langenhuijsen to delegate its power of attorney rights to registered patent attorneys or other qualified persons in other jurisdictions necessary to effect the recordal of the assignment of the Patents to Transferee with the national patent offices.

This agreement and power of attorney is governed by German law and may be executed in any number of counterparts, and this has the same effect as if the signatures on the counterparts were on a single copy of this agreement and power of attorney.






