a corporation duly organized and existing under the laws of Switzerland and having its principal office and place of business at Avenue Nestle 55, CH-1800 Vevey, Switzerland,

and its successors, assigns and legal representatives,

full and exclusive right, title and interest to:

- an invention entitled BOTTLE, METHOD OF MAKING THE SAME AND USE OF FDCA AND DIOL MONOMERS IN SUCH BOTTLE and internally registered under case number 15829,
- the application first filed at the European Patent Office on 15 December 2017 under No. 17207643.2 and entitled BOTTLE, METHOD OF MAKING THE SAME AND USE OF FDCA AND DIOL MONOMERS IN SUCH BOTTLE to protect the invention,
- the right to claim priority as to the filing date under the International Convention on the basis of the application first filed for filing patent application in all foreign countries including the United States,

- the granted patents and all related rights arising from the application first filed and the applications claiming priority of the application first filed, including, but not limited to, divisions, continuations, continuations-in-part, reissues and reexaminations thereof and substitutions of or for said applications.

ASSIGNOR does hereby grant, assign, and transfer, and hereby sets over unto ASSIGNEE, its successors, assigns and legal representatives, the full and exclusive right, title and interest to said invention in all countries including but not limited to United States of America and all other foreign countries, including, without limitation, said invention as described in the aforesaid application, to be held and enjoyed by said ASSIGNEE, its successors, assigns and legal representatives, as fully and entirely as the same would have been held and enjoyed by said ASSIGNOR had this assignment not been made, including, without limitation, all rights to the aforesaid application and to any Letters Patent including but not limited to United States Letters Patent therefor, when issued together with all improvements thereon and betterments thereof, all related applications including, but not limited to, divisions, continuations, continuations-in-part, reissues and reexaminations thereof and substitutions of or for said application, and all foreign rights including the right to make application for Letters Patent for said invention in any and all foreign countries and the right to claim priority as to the filing date under the International Convention on the basis for the aforesaid applications including but not limited to the aforesaid application for United States Patent Letters; and ASSIGNOR hereby authorizes and requests the Commissioner of Patents to issue all Letters Patent issuing therefrom to ASSIGNEE, for its interest as ASSIGNEE, its successors, assigns and legal representatives.

ASSIGNOR hereby agrees to execute any papers, provide any information and testify in any interference or litigation at the request of ASSIGNEE, its successors, assigns and legal representatives, when deemed essential to ASSIGNEE's, its successors', assigns' and legal representatives' full enjoyment, protection, enforcement and title in and to such invention and rights hereby transferred.

ASSIGNOR furthermore agrees upon request of said ASSIGNEE, its successors, assigns and legal representatives, and without further remuneration, to execute any and all documents desired by said ASSIGNEE, its successors, assigns and legal representatives, for the filing and granting of foreign applications and the perfecting of title thereto in said ASSIGNEE, its successors, assigns and legal representatives.

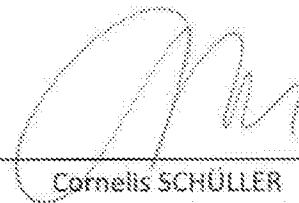
