## PATENT ASSIGNMENT

This PATENT ASSIGNMENT (“**Patent Assignment**”), dated as of April 5, 2022 is made by Sierra Wireless America, Inc. (“**Transferor**”), a Delaware corporation, in favor of Omnilink Systems Inc. (“**Transferee**”), a Delaware corporation.

WHEREAS, Transferor and Transferee are parties to a Contribution Agreement dated on or about the date hereof, pursuant to which Transferor transfers certain assets to Transferee, including the Patent Rights (as defined below);

WHEREAS, Transferor and Transferee wish to enter into this Patent Assignment to confirm the transfer of the Patent Rights from Transferor to Transferee, for recording with the United States Patent and Trademark Office and corresponding entities or agencies in applicable jurisdictions;

NOW THEREFORE, the parties agree as follows:


1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Transferor hereby contributes, transfers, assigns, conveys and delivers to Transferee, and Transferee does hereby acquire and accept from Transferor, all of Transferor’s right, title and interest in, to and under the following (the “**Patent Rights**”):
  - (a) the patents and patent applications set forth in Schedule 1 hereto (the “**Patents**”);
  - (b) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and
  - (c) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.
2. Recordation and Further Actions. Transferor hereby authorizes the Commissioner for Patents in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Patent Assignment upon request by Transferee. Following the date hereof, at Transferee’s expense, Transferor shall take such reasonable steps and actions, and provide such reasonable cooperation and assistance to Transferee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Assigned Patent Rights to Purchaser, or any assignee or successor thereto.
3. Terms of the Contribution Agreement. The parties hereto acknowledge and agree that this Patent Assignment is entered into pursuant to the Contribution Agreement, to which

reference is made for a further statement of the rights and obligations of Transferor and Transferee with respect to the Patent Rights. The representations, warranties, covenants, agreements, and indemnities (if any) contained in the Contribution Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Contribution Agreement and the terms hereof, the terms of the Contribution Agreement shall govern.



- 5. Successors and Assigns. This Patent Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

This Patent Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Patent Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
