Pursuant to UCA §16-10a part 10, the individual named below causes this Amendment to the Articles of Incorporation to be delivered to the Utah Division of Corporations for filing, and states as follows:

1. The name of the corporation is: CLUSTER RESOURCES, INC.
2. The date the following amendment(s) was adopted: MARCH 13, 2009
3. If changing the corporation name, the new name of the corporation is:
ADAPTIVE COMPUTING ENTERPRISES, INC.

- 1) The Corporation hereby amends the Articles of Incorporation to change the name to Adaptive Computing Enterprises, Inc.
- 2) Article III is hereby amended and replaced in its entirety as follows:

ARTICLE THREE. Stock. The Corporation shall have the authority to issue 100,000,000 shares of stock with 10,000,000 shares as common voting stock with unlimited voting rights as provided in the Utah Revised Business Corporation Act and 90,000,000 shares as non-voting stock.
