Assignor hereby authorizes and requests the appointed attorneys to insert above the serial number and filing date of said application when known.

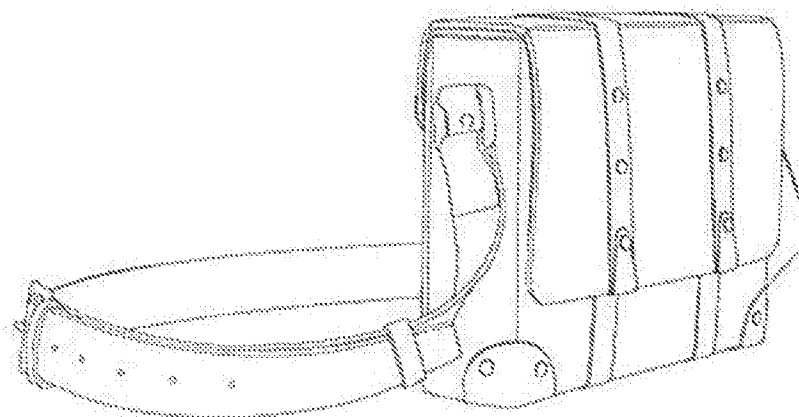
