

Pursuant to, and upon the terms of, the Transfer Agreement, Assignor, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby sell, convey, transfer and assign and does hereby confirm having sold, conveyed, transferred and assigned to Assignee, and Assignee hereby accepts the sale, conveyance, transfer and assignment and hereby confirms having accepted the sale, conveyance, transfer and assignment of all right, title and interest of Assignor in, to and under the Patents, together with all of Assignor's rights to sue for past, present or future infringement of said Patents together with all claims for damages by reason of past, present or future infringement of said Patents, and the right to sue for and collect the same for Assignee's own use and enjoyment, all to be held and enjoyed by said Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had this Confirmatory Assignment not been made.
4. At Assignee's sole cost and expense, Assignor shall execute and deliver such other documents and take all other commercially reasonable actions which Assignee, its successors and/or assigns, may reasonably request to effect the terms of this Confirmatory Assignment, including its recordation in relevant state and national patent offices.
5. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any other official of any applicable governmental authority to record Assignee as assignee and owner of the entire right, title and interest in and to the Patents.






