ASSIGNMENT

WHEREAS, BONNELI AB, a private limited company organized under the laws of Sweden (hereinafter referred to as the "Assignor") represents that pursuant to an Employment Agreement between BONNELI AB and BENGT ROSLANDER (hereinafter "Inventor") dated 1 January 2018 Assignor is the owner of Bengt Roslander's entire right, title and interest as a joint inventor of a JOINING SYSTEM FOR FLOOR PANELS (hereinafter referred to as the "Invention") for which Application for United States Letters Patent, Application No. 16/965,063, was filed on 27 July 2020 under 35 USC §371, said application claiming priority of PCT/EP2019/051939, and

WHEREAS, VILOX AB, a private limited company organized under the laws of Sweden having an office Mangårdagatan 57, 256 67 Helsingborg SE (hereinafter referred to as the "Assignee") desires to acquire the Assignor's entire right, title and interest in and to said Invention;

This assignment includes, without limitation, all files, documentation, records, specifications, emails, letters, diagrams, spreadsheets, and the like relating to the Application; all patents (the "Patents") that issue from any one or more of the Application; all rights to claim the priority date under United States law, the Patent Cooperation Treaty and/or other international arrangements of any earlier United States or other applications; all rights to sue, to bring any cause of action, and to enforce, including all rights to recover damages, injunctive relief and other remedies for past, present, and future infringements of any of the foregoing; all rights to collect royalties and other payments under or on account of the Application and/or the Patents, any and all other rights and interests arising out of, in connection with, or in relation to the Application and/or all inventions that any one or more of the Application disclose, the same to be held and enjoyed by Assignee entirely as if the same would have been held and enjoyed by Assignor had this sale and assignment not been made.


(2) **Miscellaneous.** If any part of this Assignment shall be held by a court of competent jurisdiction to be void, invalid, or inoperative, the remaining provisions of this Assignment shall not be affected and shall continue in effect.


