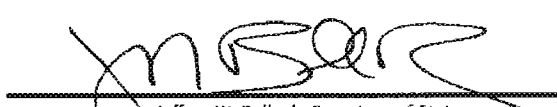

Pursuant to Section 18-209 of the Limited Liability Company Act of the State of Delaware  
and Section 264 of the General Corporation Law of the State of Delaware

FIRST: The name and jurisdiction of formation or organization and domicile of each of the constituent entities is: Monaco SpinCo Inc., which was organized as and is a Delaware corporation (the "Corporation") and Mead Products LLC, which was formed as and is a Delaware limited liability company (the "LLC").

SECOND: The Corporation and the LLC have entered into an Agreement and Plan of Merger, dated as of May 1, 2012 (the "Merger Agreement"), providing for the merger of the Corporation with and into the LLC pursuant to Section 18-209 of the Limited Liability Company Act of the State of Delaware (the "DLLCA") and Sections 251 and 264 of the General Corporation Law of the State of Delaware (the "DGCL"). The Merger Agreement has been approved, adopted, certified, executed and acknowledged in accordance with Sections 18-204 and 18-209 of the DLLCA in the case of the LLC and Sections 103, 251 and 264 of the DGCL in the case of the Corporation.

THIRD: The LLC shall be the surviving entity of the merger. The certificate of formation and the limited liability company operating agreement shall be the certificate of formation and the limited liability company operating agreement of the LLC.

FOURTH: The Merger Agreement is on file at the offices of the LLC at 300 Tower Parkway, Lincolnshire, IL 60069. A copy of the Merger Agreement will be furnished, on request and without cost, to any stockholder of the Corporation or to any member of the LLC.

FIFTH: This Certificate of Merger and the merger shall be effective upon filing with the Secretary of State of the State of Delaware.

IN WITNESS WHEREOF, the LLC has caused this Certificate of Merger to be signed by its duly authorized officer in its corporate name as of May 1, 2012.
