SUPPLEMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Supplement to Intellectual Property Security Agreement (this “*Supplement*”) is made as of May 5, 2022 by and between **SILICON VALLEY BANK**, a California corporation (“*Bank*”), and **CD NEWCO, LLC**, a Delaware limited liability company (as “*Grantor*”).

WHEREAS, Grantor, among others, executed and delivered an Intellectual Property Security Agreement dated December 24, 2020 (as amended of record from time to time hereinafter, the “*IP Agreement*”) in favor of the Bank, pursuant to which Grantor pledged, assigned and granted a security interest in certain Intellectual Property Collateral, which was recorded with (i) the Patent division of the United States Patent and Trademark Office on December 28, 2020 at Reel 054854, Frame 0252 and (ii) the Trademark division of the United States Patent and Trademark Office on December 28, 2020 at Reel 7147, Frame 0275.

WHEREAS, the Grantor has developed additional patents, and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional intellectual property in favor of Bank.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the IP Agreement.
2. Supplement to Exhibit B. Exhibit B to the IP Agreement is hereby supplemented, but not replaced, by Exhibit B annexed hereto.
3. Miscellaneous:
 - a. Except as provided herein, all terms and conditions of the IP Agreement remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
 - b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
