DEED OF ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS

THIS DEED dated

BETWEEN Auramer Bio Limited (in Liquidation) (NZBN: 9429041974803) (**Assignor**)

AND Biogenes Technologies Sdn Bhd (SSM: 201501018057) (**Assignee**)

(together, the **Parties**)

BACKGROUND

- A. The Parties acknowledge that the Assignor holds the below Patents and Copyright Material.
- B. The Assignor wishes to transfer all of the Assignor's Intellectual Property Rights to the Assignee on the terms of this Deed.

OPERATIVE PART

1. DEFINITIONS

- 1.1 **Copyright** shall mean all copyright as may subsist anywhere in the world in the Copyright Work.

Copyright Material shall mean the nucleic acid sequence associated with each individual aptamer identified in the Target Package as set out in Schedule Two.

Copyright Work shall mean:

- (a) Any work that relates to the Patents or Technical Information; and
- (b) The Copyright Material.

Deed shall mean this deed of assignment.

Improvement shall mean any improvement, modification or development of or to any of the Inventions, Technical Information and Copyright Material in existence at the date of this Deed.

Intellectual Property Rights shall mean all intellectual property rights whatsoever relating to the Inventions, including the Patents, Patent Rights, Copyright and proprietary rights in relation to the Technical Information, and for the avoidance of doubt includes any intellectual property rights in or to any Improvements in existence at the date of this Deed.

Inventions shall mean the invention(s) the subject of any of the Patents, Technical Information and Copyright Material, including any Improvements existing at the date of this Deed.

Invoice means the invoice/s from the Assignor addressed to the Assignee in relation to the Intellectual Property Rights.

Patents shall mean the patents and patent applications as set out in Schedule One.

Patent Rights shall mean:

- (a) the right to apply for any patent relating to the Inventions or equivalent protection in any country of the world and to claim priority under any international convention from any such application(s) and the rights conferred by such patents or equivalent protection when granted; and
- (b) the rights conferred by the Patents (together with any patents that may be granted pursuant to the Patents) including the right to claim priority under any international convention and right conferred by such Patents now and/or when withdrawn, abandoned, cancelled or disclaimed.

Technical Information shall mean all inventions, designs, drawings, tests, reports and procedures, models, manuals, formulae, tables of operation conditions and the like relating to the Patents and all other information, knowledge, know-how and show-how relating to the foregoing, whether or not capable of being protected by patent or otherwise.

2. TRANSFER AND ASSIGNMENT

- 2.1 In consideration for the payment prescribed at clause 2.2, the Assignor hereby transfers and assigns all its rights, title and interests in and to the Intellectual Property Rights to the Assignee.
- 2.2 The Assignee agrees to pay the sum set out in the Invoice/s to the Assignor in consideration for the assignment.
- 2.3 The assignment will take effect on the date this Deed is fully executed by the Parties.
- 2.4 The assignment effected by clause 2.1 includes:
 - (a) the assignment and transfer of the right to sue for damages for infringement or misuse of the Intellectual Property Rights; and
 - (b) all other rights of action, powers, legal and equitable remedies, and benefits arising from ownership of the Intellectual Property Rights,

in relation to all causes of action arising before, on or after the date of this Deed.

3. ASSIGNOR OBLIGATIONS

- 3.1 The Assignor undertakes to execute any documents and authorisations to vest absolutely all its right, title and interest to the Intellectual Property Rights in favour of the Assignee.
- 3.2 The Assignor agrees to treat as confidential, all information relating to the Patents, Copyright Work, Technical Information and Intellectual Property Rights and shall not use, disclose or publish the same with the express prior written consent of the Assignee. Such obligations shall not extend to information which already is in or which enters the public domain through no fault of the Assignor, jointly or severally. The Assignor agrees to seek prior clearance from the Assignee in any case of uncertainty.

4. ASSIGNOR WARRANTIES

- 4.1 The Assignor warrants that (to the best of their knowledge):

- (a) The Assignor has absolute title to the Intellectual Property Rights;
- (b) There are no encumbrances or other matters affecting the Assignor's capacity to assign the Patents and/or Intellectual Property Rights to the Assignee free of any encumbrances or interests whatsoever; and
- (c) Any Copyright Work is (to the best of their knowledge) the Assignor's original work and is not copied in whole or in part from any other work.


5. COUNTERPART


