JUDGMENT ORDER

On October 17, 2019, this Court heard Plaintiffs' Motion to Enforce Settlement Agreement. The Court, for the reasons set forth at the hearing and in the subsequent Order, GRANTED the motion and hereby enters judgment in favor of Plaintiffs as follows.

The Court ORDERS that Plaintiffs recover from Defendant SaviCorp, Inc. the sum of \$121,956.95, consisting of the damages, interest and fees identified in the Court's Order Enforcing Settlement.

The Court ORDERS that Plaintiffs recover from Serge V. Monros the sum of \$88,723.17, consisting of the damages, interest and fees identified in the Court's Order as to Defendant Monros.

Post-judgment interest on each of the foregoing awards shall accrue as provided by 28 U.S.C. 1961.

The foregoing judgments arise from a common claim. It is ORDERED that payment of any sum with regard to either judgment shall be accounted as a satisfaction, on a dollar-for-dollar basis, of the other judgment, and the maximum to be recovered shall be \$121,956.95.




