TO AMENDED AND RESTATED  
CERTIFICATE OF INCORPORATION OF  
CARROT INC.**

Carrot Inc., a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the “**General Corporation Law**”),

DOES HEREBY CERTIFY:

1. That the name of this corporation is Carrot Inc. and that this corporation was originally incorporated pursuant to the General Corporation Law on March 20, 2015 under the name Carrot Sense, Inc. and the Certificate of Incorporation of the corporation was amended and restated on March 31, 2015, June 29, 2016, August 8, 2017, October 10, 2018, March 23, 2020 and September 29, 2021.

2. This Certificate of Amendment to Amended and Restated Certificate of Incorporation was duly adopted in accordance with Section 242 of the General Corporation Law, and restates, integrates and amends the provisions of the Amended and Restated Certificate of Incorporation of this corporation.

3. Article FIRST of the Amended and Restated Certificate of Incorporation is hereby amended and restated in its entirety to read as follows:

“FIRST: The name of this corporation is Pivot Health Technologies Inc. (the “Corporation”). The Corporation’s initial Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on March 20, 2015, under its original name, Carrot Sense, Inc.”
