## PATENT ASSIGNMENT

Assignor hereby sells, conveys, transfers, assigns and delivers to Assignee, and Assignee does hereby acquire and accept, all of Assignor's worldwide right, title and interest in, any improvements which are disclosed in the inventions identified in SCHEDULE B-1 hereto ("Assigned IP"), including without limitation (i) all Letters Patents and applications for Letters Patents therefor in the United States Patent and Trademark Office, and the Patent Offices of other nations throughout the world, all rights therein provided by international treaties or conventions, and any legal equivalent thereof, including all rights to claim priority thereto, (ii) all continuations, continuations-in-part, divisionals, extensions, renewals, reissues, re-examinations, or substitutes of the foregoing, and any legal equivalents thereof, (iii) all income and royalties due or payable to Assignor with respect thereto, and (iv) all claims against a third party by reason of past, present, or future infringements, together with damages and payments thereto.

3. The Parties acknowledge and agree that the terms contained in the Assignment Agreement shall not be superseded hereby but shall remain in full force and effect to the fullest extent provided therein. In the event of any conflict or inconsistency between the terms of the Assignment Agreement and the terms of this Assignment, the terms of the Assignment Agreement shall govern.

4. Upon the reasonable request by Assignee, Assignor shall execute all documents and take all actions as may be necessary to enable Assignee to perfect, enforce, defend, register and/or record its right, title and interest in, to and under the Assigned IP, in each case, without further compensation but at the expense of Assignee.

5. Assignor hereby authorizes and requests the officials of the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign jurisdiction, to record and register Assignee as assignee and owner of entire right, title and interest in, to and under the Assigned IP.
