WHEREAS, BTL MEDICAL TECHNOLOGIES S.R.O., a company established and existing under the laws of the Czech Republic, having a place of business Evropská 423/178, Vokovice, 160 00 Prague 6, Czech Republic ("ASSIGNOR") owns certain patents, patent applications, and/or registrations, including but not limited to the assets set forth in Attachment 1 attached hereto and incorporated herein by this reference ("PATENTS");

WHEREAS, ASSIGNOR participated in the process of a demerger by spin-off, resulting in the transfer of certain assets to BTL HEALTHCARE TECHNOLOGIES A.S., a corporation established and existing under the laws of the Czech Republic, having a place of business at Štěpánská 535/6, Nové Město, 120 00 Prague 2, Czech Republic ("ASSIGNEE");

WHEREAS, ASSIGNOR and ASSIGNEE executed a common Project of Demerger by Spin-off on 27 APRIL 2021 2021 ("Project"), according to which upon registration of the Project with the Czech Commercial Register, ASSIGNOR shall be divided and certain of its assets and liabilities, including among others the PATENTS, shall pass, subject to any existing licenses, liens, or encumbrances, to ASSIGNEE, pursuant to Section 59 (1) in connection with Section 244 (2) of the Act No. 125/2008 Coll., on Transformations of Companies and Cooperatives, as amended;

WHEREAS, on 31 MAY 2021 2021 the sole shareholder of both ASSIGNOR and ASSIGNEE adopted decisions on approval of the Project in the capacity of General Meetings of both companies in a form of the notarial deeds and on the basis of these decisions the Project shall be registered with the Czech Commercial Register i.e. legally effective on 1 JUNE 2021 2021;

NOW, THEREFORE, ASSIGNOR and ASSIGNEE hereby confirm that by virtue of the Project the PATENTS are passed, transferred, conveyed, assigned, and delivered effective 1 JUNE 2021 2021 to ASSIGNEE, including, without limitation, all rights and causes of action for infringement or misappropriation (past, present or future) of any PATENT, all rights to apply for or register any of the foregoing, and any and all other rights and interests arising out of, in connection with or in relation to the PATENTS.
