**ASSIGNMENT OF PATENT RIGHTS**

2. **ASSIGNEE** shall file such notices or registration with relevant patent offices as are necessary to perfect the agreement, all costs to be borne by **ASSIGNEE**. **ASSIGNOR** agrees to sign or otherwise execute all such documents.
3. **ASSIGNMENT** may be executed in any number of counterparts, each of which will be deemed an original, but all of which together constitute one and the same instrument. Executed signature pages to this assignment may be delivered by facsimile, or by email in portable document format (.pdf) and delivery of the signature page by such method will have the same effect as if the original signature had been delivered by the sending party to the receiving party.
