DEED OF ASSIGNMENT

THIS DEED is made on the date it is signed by the last of the parties.

BETWEEN Queensland University of Technology (ABN 83 791 724 622) of 2 George Street Brisbane QLD, 4000; ("Assignor") and

AND qutbluebox Pty Ltd (ABN 34 118 773 096) as trustee for the QUT Bluebox Trust (ABN 97 041 405 905) of 88 Musk Avenue, Kelvin Grove, Queensland 4059, ("Assignee")

RECITALS

A. Whereas the Assignee wishes to acquire all of the rights, title and interest in and to the patents identified in the Schedule ("the Patents");

And

B. Whereas the Assignor is agreeable to the Assignee acquiring all of the rights, title and interest in and to the Patents

Therefore the Assignor and the Assignee agree as follows:

ASSIGNMENT

1. In return for valuable consideration, the receipt and sufficiency of which is acknowledged by each of the Assignors and in accordance with the agreement between the Assignor and the Assignee dated 15 November 2019, the Assignor hereby assigns to the Assignee their entire interest in the Patents, including:
 - a. their rights, if any, to sue for any infringement of the Patents which took place prior to the date of this Deed of Assignment (Deed), or which takes place prior to recordal of this Deed; and
 - b. their rights, if any, to apply for and obtain other patents claiming priority from or otherwise based on the Patents.
2. A party to this Deed must, upon the request of the other party, do all things reasonably desirable to give effect to clause 1, including by executing further documents.
3. This Deed is effective from the date in Clause 1 of this Deed.
4. This Deed is governed by the laws of Queensland, Australia and each party irrevocably submits to the non-exclusive jurisdiction of the courts of Queensland, Australia.

5. This Deed may be executed in counterparts. All executed counterparts constitute one document.


