THE ASSIGNOR further agrees that, upon request by ASSIGNEE in order to fully secure and vest in the ASSIGNEE, its successors, and assigns the entire right, title, and interest in and to said patents and patent applications, ASSIGNOR will, at the sole cost of ASSIGNEE, execute any and all assignments, affidavits, declarations, and other documents for filing in the U.S. Patent and Trademark Office or its equivalents throughout the world, and will communicate to said ASSIGNEE, its successors, heirs, and assigns all facts known to the ASSIGNOR relating to said invention and the history thereof, and will generally perform such other acts as reasonably necessary to fully secure and vest in the ASSIGNEE, its successors and assigns, the entire right, title, and interest in and to said patents and patent applications.

THE ASSIGNOR represents and agrees that no assignment, grant, mortgage, license, or other agreement affecting the rights and interests herein conveyed has been or will be made to others by the ASSIGNOR, and that full rights to convey the same as herein expressed are possessed by the ASSIGNOR.

THE ASSIGNOR hereby authorizes and requests the respective national Patent Offices to officially record the ASSIGNEE as sole and exclusive owner of any and all said patents and patent applications.

ASSIGNOR further hereby authorizes and requests the respective national Patent Offices to issue any and all Letter Patents which may be granted upon any of said applications, to BIOTECERA, INC., as the assignee of its entire right, title, and interest therein.

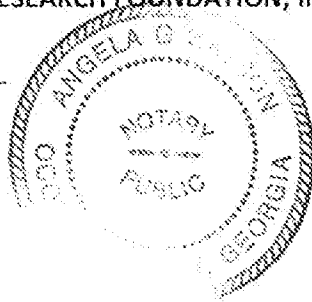
