Such cooperation by said Assignor shall include reasonable production of pertinent facts and documents, giving of testimony, execution of petitions, oaths, specifications, declarations or other papers, and other reasonable assistance to Assignee (a) for perfecting in said Assignee the right, title and interest herein conveyed; (b) for prosecuting any of said applications; (c) for filing and prosecuting substitute, divisional, continuing or additional applications covering said invention; (d) for filing and prosecuting applications for reissuance of any said patents; (e) for interference or other priority proceedings involving said invention; and (f) for legal proceedings involving said invention and any applications therefore and any patents granted thereon, including without limitation opposition proceedings, cancellation proceedings, priority contests, public use proceedings, infringement actions and court actions; provided, however, that any expense incurred by said Assignor in providing such cooperation shall be paid for by said Assignee.




