
(4) in and to all applications filed under International Conventions on the invention or claiming priority to the PCT patent application or the provisional application.



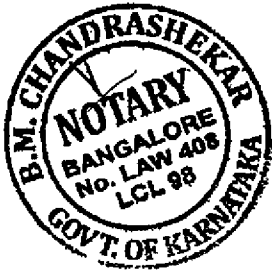

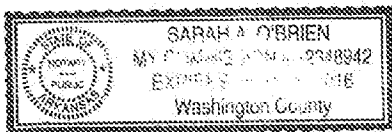
