Introduction

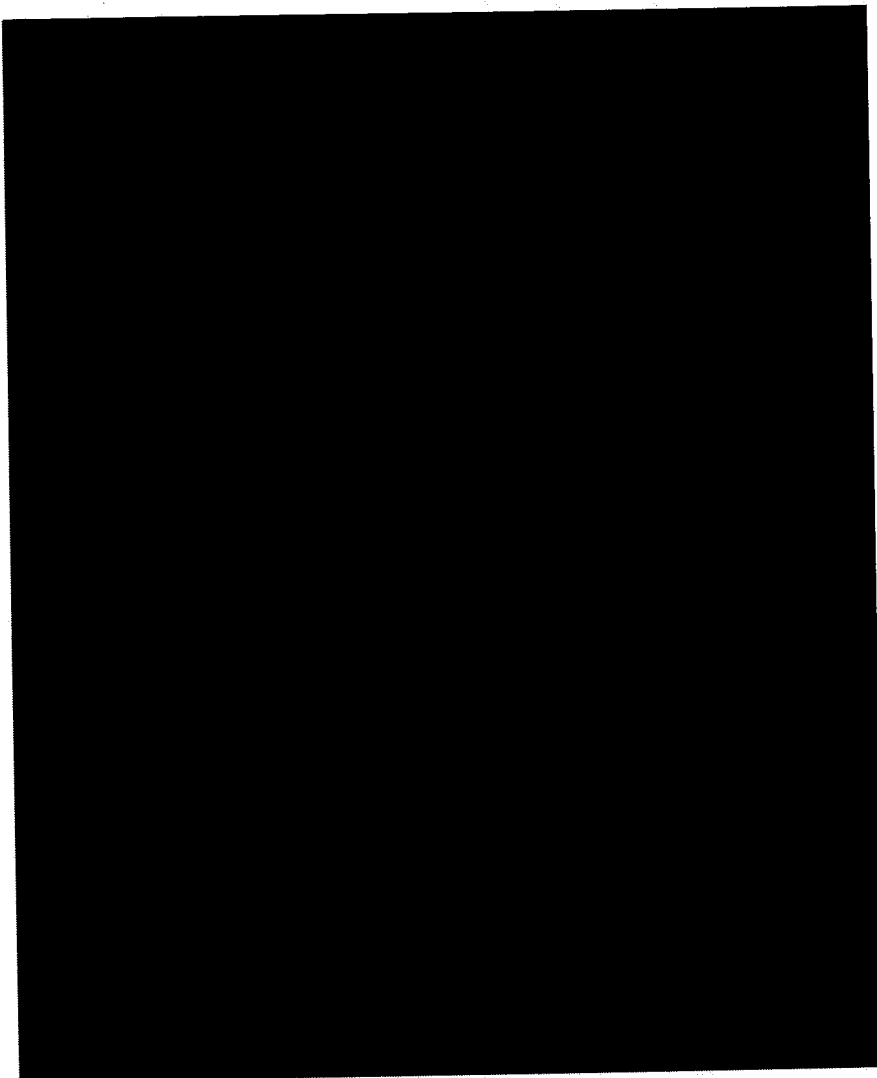
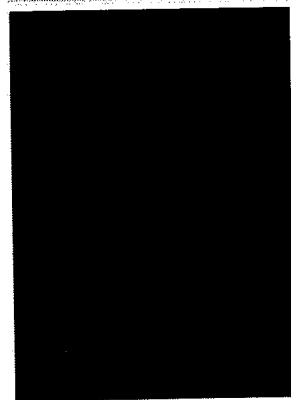
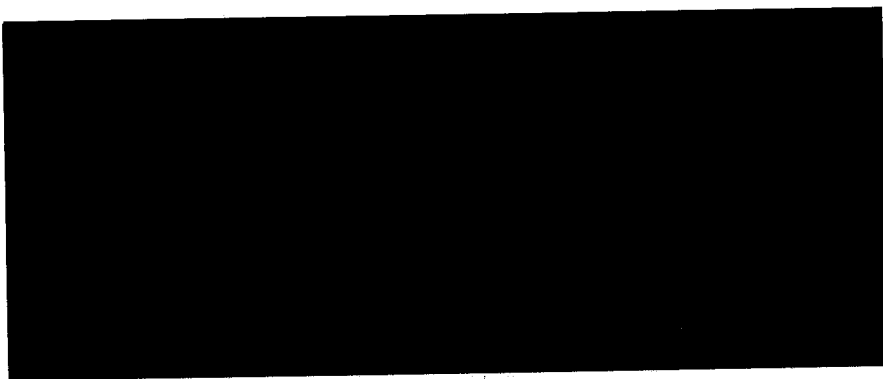

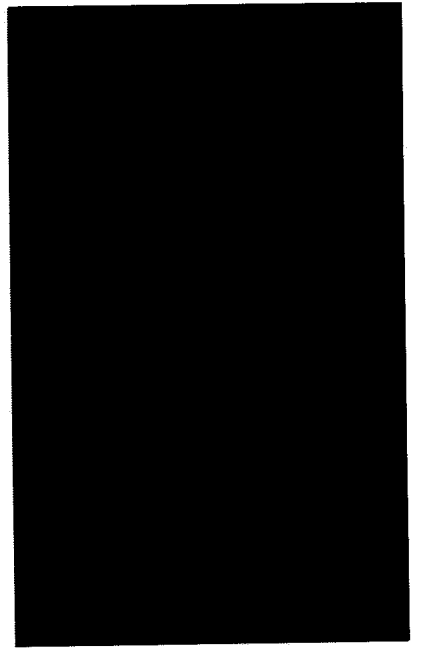
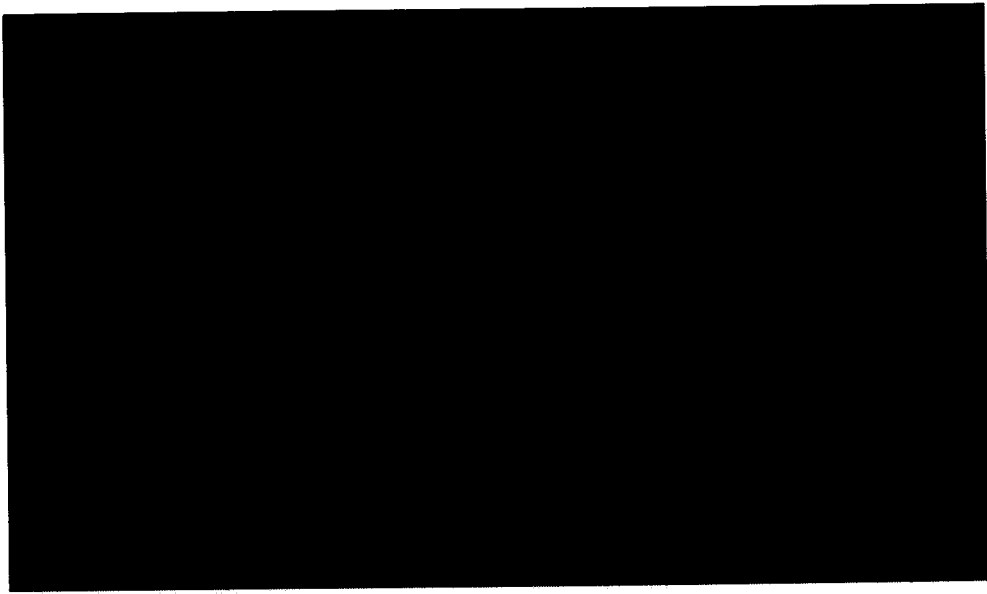
Intellectual property obligations

The definition of *proprietary information* is broad, and includes all intellectual property and other proprietary rights, including rights in copyrightable works such as marketing or media plans or materials, computer software and related specifications, designs and documentation, any ideas, improvements, innovations, inventions, processes, techniques (whether patentable or unpatentable) and any patents or similar applications or registrations in respect to any of the foregoing, any know-how, show-how, confidential information or trade secrets, any industrial designs, or database rights or other proprietary rights that may be protected by any statute or legislation, any trademarks, trade names, business names, logos or similar designations that may be protected by law, statute or legislation, which you make or discover by yourself or with others in your job with Shopify or which arise, directly or indirectly, from your job with Shopify, and which pertain to a business Shopify is engaged in, is reasonably expected to engage in, or in which it has previously expressed an intention to engage in.

You will promptly notify Shopify about all proprietary information you develop. You agree that all proprietary information will be Shopify's property and you hereby assign all of your rights in all proprietary information to Shopify. You fully waive all moral rights you may have in all proprietary information in favour of Shopify. You will assist us (without charge but at no expense to you) at any time, including after the end of your job with Shopify, and in every way to obtain and enforce registered intellectual property rights relating to proprietary information anywhere in the world. You may be required to sign additional or separate documents to record or confirm your assignment of proprietary information to us. If you do not do something required by us to allow Shopify to obtain or enforce registered intellectual property rights relating to proprietary information, you agree and authorize Shopify to take such action on your behalf and in your name.

We recognize you may have prior inventions you wish to exclude from these promises. If you do, please let us know prior to signing this agreement, and we'll make the appropriate changes to this agreement to exclude those inventions.

Your second obligation is to ensure that proprietary information is assigned to Shopify and will be available for use by Shopify.



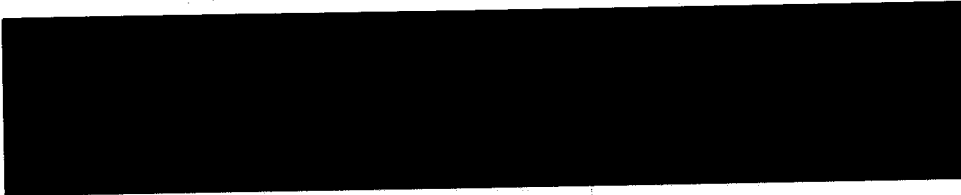

SECTION 5

General matters



Each promise in this agreement is a separate commitment made by you. If any promise made by you is found by a court to be invalid, that promise will be removed from this agreement, but your other promises won't be affected. If at some point we don't enforce one of your promises, that won't prevent us from enforcing that promise at some later time. Your promises in this agreement will continue after the end of your job for any reason. This agreement can only be modified by another written document signed by both you and us. This agreement is governed by the laws of the Province of Ontario and the laws of Canada applicable in Ontario. You agree that if you have any disputes with us, those disputes will be dealt with in the Ontario courts.
