**TERMINATION AND RELEASE  
OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY**

This Termination and Release of Security Interests in Intellectual Property (“Intellectual Property Release”) is made as of May 11, 2022, by **TRUIST BANK** as collateral agent (the “Collateral Agent”), in favor of **REVCYCLE+, INC.**, a Delaware corporation, **T-SYSTEM, INC.**, a Texas corporation, **TRUST HEALTHCARE CONSULTING SERVICES, LLC**, a Missouri limited liability company, and **VERSALUS HEALTH, LLC**, a Delaware limited liability company (the “Grantors” and each, a “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantors entered into Intellectual Property Security Agreements granting security interests in certain intellectual property, dated as of December 31, 2019 and December 31, 2020 (each as amended, amended and restated, supplemented or otherwise modified from time to time, an “Intellectual Property Security Agreement”), with the Collateral Agent.

WHEREAS, for the purpose of recording the security interest with respect to the Released Collateral (as defined below), the respective Intellectual Property Security Agreements were recorded with the United States Patent and Trademark Office on January 8, 2020 at Reel/Frame 051448/0300 (patents) and at Reel/Frame 6833/0309 (trademarks), the United States Copyright Office on January 8, 2020 assigned SR#1-8494480950, and with the United States Patent and Trademark Office on January 4, 2021 at Reel/Frame 7154/0093 (trademarks).

Capitalized terms used but not otherwise defined herein have the meanings given to them in the respective Intellectual Property Security Agreements.

WHEREAS, the Grantors granted the Collateral Agent for the ratable benefit of the holders of the Secured Obligations (as defined in the Security Agreement described in the Intellectual Property Security Agreements), under the terms of the Intellectual Property Security Agreements, a security interest and continuing lien in favor of the Collateral Agent, in and to such Grantor’s right, title and interest in and to the Collateral (as defined in the Intellectual Property Security Agreements) (the “Security Interest”).

WHEREAS, the Collateral Agent has agreed to terminate and release its Security Interest in and to the Collateral, including (i) all patents and patent applications included in the Collateral, including, without limitation, those set forth in Schedule A, (ii) all trademark and service mark registrations and applications included in the Collateral, including, without limitation, those trademark and service mark registrations and applications set forth in Schedule B, (iii) all copyrights, whether registered or unregistered, included in the Collateral, including, without limitation, those copyright registrations and applications and exclusive copyright licenses set forth on Schedule C, (iv) all reissues, divisionals, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, as applicable, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of any Grantor accruing thereunder or pertaining thereto, (v) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages, and (vi) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing (collectively, the “Released Collateral”).

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the holders of the Secured Obligations, in association with the

security interest under the Security Agreement, hereby, without recourse and without representation or warranty of any kind (either express or implied), cancels, releases, terminates and discharges any and all of its right, title and interest in the Released Collateral of each Grantor, including any and all goodwill relating to the same, and assigns, transfers and conveys to each Grantor any and all of its right, title and interest in such Released Collateral, including any and all goodwill relating to the same, as applicable.

The Collateral Agent authorizes and requests that the Commissioner for Patents, Commissioner for Trademarks, Register of Copyrights and any other applicable government officer record this Intellectual Property Release.

This Intellectual Property Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
