present, or future infringement or any other violation of patent or patent application rights; to have hold for the sole and exclusive use and benefit of the Assignee, its successors and assigns, to the full end of the term or terms for all such patents. The Assignor sells, assigns and transfers the entire right, title and interest to the Assignee as of the day of execution of this Assignment.

The Assignor hereby consents that a copy of this Assignment shall be deemed a full legal and formal equivalent of any document that may be required in any country in proof of the right of the Assignee to apply for patent or other form of protection for the invention or inventions and to claim the aforesaid benefit of the right of priority.

The Assignor requests that any and all patents for the invention or inventions be issued to the Assignee in the United States and in all countries foreign to the United States or to such nominees as Assignee may designate.




