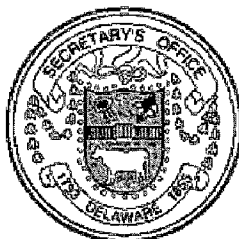

STATEMENT OF NAME CHANGE AND MERGER

Hayward Baker, Inc., a Delaware corporation (the "Corporation"), hereby certifies to the State Department of Assessments and Taxation of Maryland ("SDAT") that the instrument under which the Corporation was organized has been amended, changing the name of the Corporation to "Keller North America, Inc."
