## TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “Termination”), dated as of June 3, 2022, is executed by each of secured parties listed on the signature pages hereto (collectively, the “Holders” and, individually, a “Holder”) and Liberty Global Ventures Group Ltd. (“Liberty”), as agent for the Holders (the “Lender Representative”), in favor of IOTAS, INC., a Delaware corporation (the “Company”). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

### RECITALS

A. Pursuant to that certain Intellectual Property Security Agreement, dated as of March 31, 2021 (the “Security Agreement”), by and among the Company, the Lender Representative, and the Holders, the Company granted to the Lender Representative, for the benefit of the Holders, a security interest in the Company’s intellectual property.

B. The Security Agreement was recorded with the (i) Patent Division of the United States Patent and Trademark Office at Reel/Frame 055815/0322 (as described in Exhibit A attached hereto) to evidence the security interest granted under the Security Agreement.

C. The Lender Representative and the Holders agree to execute this Termination in order to evidence the termination and release of the security interest in the Company’s intellectual property.


### AGREEMENT
