

RESOLVED: That the Amended and Restated Certificate of Incorporation of the Corporation is hereby amended by striking out Article FIRST thereof and by substituting in lieu of said Article the following new Article FIRST:

“FIRST: The name of this corporation is: ChaosSearch, Inc. (the “**Corporation**”).”
