ACKNOWLEDGMENT OF SECURITY INTEREST IN PATENTS

March 18, 2022

WHEREAS, CLEAR ARCH HEALTH, LLC, a Delaware limited liability company (f/k/a RESIDEO LIFE CARE SOLUTIONS LLC, a Delaware limited liability company) ("Grantor"), has adopted, used and is using, and holds all right, title and interest in and to, the patents listed on the attached Schedule 1, which patents are registered or applied for in the United States Patent and Trademark Office (the "Patents");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Grantor and Administrative Agent, Grantor does hereby grant to Administrative Agent for the benefit of Lenders a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

Grantor does hereby further acknowledge and affirm that the rights and remedies of Administrative Agent with respect to the Collateral are more fully set forth in the Collateral Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


