

CONFIRMATION OF ASSIGNMENT AND QUITCLAIM

This Confirmation of Assignment and Quitclaim Agreement (the "Agreement") is by and between Laser Endo One, LLC, an Arizona limited liability company, formerly known as Medical Dental Advanced Technologies Group, LLC (hereinafter "LASER ENDO ONE"), and Pipstek, LLC, a Delaware limited liability company (hereinafter "PIPSTEK").

Recitals

WHEREAS, on January 1, 2016, LASER ENDO ONE, as part of a Patent-IP Rights Assignment between PIPSTEK and LASER ENDO ONE (appended as Exhibit 2), agreed to assign and did assign to PIPSTEK all right, title, and interest in and to the following property ("Intellectual Property Assets"):

- (i) certain new and useful improvements and designs relating to LASER BASED ENHANCED GENERATION OF PHOTOACOUSTIC PRESSURE WAVES IN DENTAL AND MEDICAL TREATMENTS AND PROCEDURES, ENERGETICALLY ACTIVATED BIOMEDICAL NANOTHEURAPEUTICS INTEGRATING DENTAL AND MEDICAL TREATMENTS AND PROCEDURES, BIOMEDICALLY ACTIVE NANOTHEURAPEUTICS INTEGRATING DENTAL AND MEDICAL TREATMENTS AND PROCEDURES, DENTAL AND MEDICAL TREATMENTS AND PROCEDURES, PERIODONTAL AND MEDICAL TREATMENT SYSTEMS, PERIODONTAL TREATMENT SYSTEM AND METHOD, and SYSTEM AND METHOD FOR TREATMENT OF ENDODONTIC/PERIODONTIC CONDITIONS (collectively "the Inventions");
- (ii) the associated intellectual property rights, throughout the World, in the Inventions including the patents and patent applications identified in Exhibit 1; any and all parent or continuing patents and applications thereof including divisionals, continuations, provisionals, substitutions and continuations-in-part; any and all reissues, reexaminations and extensions thereof; and any and all corresponding foreign patent applications and patents (collectively "the Patents and Patent Applications"); and
- (iii) all rights, title, and interests embodied in or pertaining in any way to LASER ENDO ONE's laser device and its method of cleaning teeth and performing various other medical treatments, including treatments of root canals, caries, periodontics, and other medical and/or dental procedures ("the Technology") referenced in Exhibit 2 (including, but not limited to, names, trademarks, service marks, logos, all goodwill associated with any trademarks, service marks and logos, and other subject matter used in connection with the Technology);

WHEREAS PIPSTEK desires to confirm LASER ENDO ONE's prior assignment to PIPSTEK of the Intellectual Property Assets and desires to obtain any remaining right, title, and interest that LASER ENDO ONE may have in and to the Intellectual Property Assets (which the parties believe is none), and LASER ENDO ONE is willing to confirm such prior assignment and

to assign to PIPSTEK any and all remaining right, title, and interest in and to the Intellectual Property Assets;

NOW, THEREFORE, in consideration of Ten U.S. Dollars (US\$10.00) to LASER ENDO ONE, and other good and valuable consideration, the sufficiency and receipt of which LASER ENDO ONE hereby acknowledges, the parties agree as follows:

- 1. Transfer of Inventions and Patents and Patent Applications.
 - a. LASER ENDO ONE acknowledges that, on January 1, 2016, LASER ENDO ONE assigned, transferred, and set over to PIPSTEK, including PIPSTEK's successors and assigns, its entire right, title, and interest in and to the Intellectual Property Assets.
 - b. LASER ENDO ONE represents and warrants that, apart from the assignment acknowledged in paragraph 1.a, before entering into this Agreement, LASER ENDO ONE had not assigned, transferred, or set over to anyone any right, title, or interest in or to any of the Intellectual Property Assets.
 - c. LASER ENDO ONE hereby quitclaims, assigns, transfers, and sets over to PIPSTEK all right, title, and interest that LASER ENDO ONE possesses (if any) in and to (i) the Intellectual Property Assets, including the patents and patent applications listed in Exhibit 1 and the Intellectual Property identified in Exhibit 2, (ii) all rights, title and interest in and to the Technology including but not limited to know-how, and (iii) all claims for damages and all remedies arising out of any violation of its interest in the Intellectual Property Assets that may have accrued prior to the effective date of this Agreement, or that may accrue thereafter, including, but not limited to, (1) the right, if any, to sue for, collect, and retain damages for past infringement of the Intellectual Property Assets before or after issuance, and (2) the right to sue for, collect, and retain damages for breach of any and all licenses relating to the Intellectual Property Assets, regardless of whether such breach occurred before or occurs after the effective date of this Agreement.
- 2. Communication and Assistance. LASER ENDO ONE shall communicate to PIPSTEK, its successors, legal representatives, and assigns any facts known to it respecting the Intellectual Property Assets immediately upon becoming aware of those facts. At the request and expense of PIPSTEK, or at the request and expense of any of PIPSTEK's successors, legal representatives, or assigns, an officer of LASER ENDO ONE shall testify in any legal proceeding involving the Intellectual Property Assets, sign all lawful papers, execute all applications, make all rightful oaths, and generally do everything reasonable to aid PIPSTEK, its successors, legal representatives, and assigns to obtain and enforce the Intellectual Property Assets in all countries.

3. General Provisions.

- a. <u>Assignments</u>. This Agreement shall be binding on, and shall inure to the benefit of any successor, assign, or legal representative of PIPSTEK, and any successor, assign, or legal representative of LASER ENDO ONE.
- b. <u>Severability</u>. Should any part or provision of this Agreement be held unenforceable or in conflict with the law of any jurisdiction, the validity of the remaining parts or provisions shall not be affected by such holding so long as the primary purpose and intentions of the parties can still be accomplished.
- c. <u>Counterparts</u>. This Agreement may be executed in two or more counterparts, each of which shall be deemed to constitute an original and shall be admissible for all purposes in action for breach of or enforcement of this Agreement.
- d. Applicable Law and Jurisdiction. This Agreement shall be governed by the laws of the State of Arizona without regard to such State's conflict of laws principles; but to the extent that interpreting or enforcing this agreement involves a question of patent law (which includes questions to which the United States Court of Appeals for the Federal Circuit applies its own law rather than state law or the law of regional circuit courts of appeal), the law of the United States Court of Appeals for the Federal Circuit shall take priority in governing that question.
- e. Attorneys' Fees. If any legal action is necessary to enforce this Agreement, the prevailing party will be entitled to reasonable attorneys' fees and expenses in addition to any other allowable relief.
- f. Entire Agreement. This Agreement constitutes the complete understanding of the parties and supersedes any and all other agreements, either oral or written, between the parties with respect to the subject matter hereof, and no other agreement, statement, or promise relating to the subject matter of this Agreement which is not contained herein shall be valid or binding. This Agreement may not be modified other than in a written document signed by both parties.
