PATENT ASSIGNMENT AGREEMENT

This PATENT ASSIGNMENT AGREEMENT (this "Patent Assignment"), made as of FEBRUARY 02, 2022 (the "Effective Date"), by and between Dr. Reddy's Laboratories, S.A., a company organized under the laws of Switzerland, located at Elisabethenanlage 11, CH-4051 Basel, Switzerland ("Assignor"), and Hatchtech Pty Limited, located at Suite 201, 697 Burke Rd, Camberwell, Victoria, 3124, Australia, (Australian Business Number 84098559409), a proprietary company organized and existing according to the laws of Victoria, Australia, ("Assignee") (collectively the "Parties"). Except as otherwise indicated herein, capitalized terms used herein shall have the meanings set forth in the Settlement and Transfer Agreement, by and between the Parties, dated February 02, 2022 (the "Agreement").

WHEREAS, under the terms of the Agreement, Assignor agreed to convey, transfer and assign to Assignee, and Assignor has agreed to acquire and assume the Assigned Patents (defined below).

NOW, THEREFORE, in consideration of the representations and warranties and mutual covenants and agreements contained in the Agreement, and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto, intending to be legally bound, agree as follows:

1. Assignment. Assignor hereby irrevocably conveys, transfers and assigns to Assignee, and Assignee hereby accepts, all of Assignor's right, title and interest in and to the following:

(a) the patents and patent applications set forth in **Schedule 1** hereto and all related continuations, continuations-in-part, divisionals, reissues, re-examinations, substitutions, and extensions thereof (the "Assigned Patents"); and

(b) any and all rights to sue and collect damages, royalties and payments for past, present and future infringement, misappropriation or other violation thereof.

2. Recordation and Further Actions. Assignor authorizes the Commissioner for Patents to record and register this Patent Assignment upon request by Assignee.

3. Further Assurances. For a period of three (3) months following the date hereof and at Assignee's sole cost and expense, the Assignor shall execute and deliver such additional documents, instruments, conveyances and assurances, prepared by Assignee, and take such further actions as may be reasonably required to carry out the provisions hereof and give effect to the transactions contemplated by this Patent Assignment, including the recordation of this Agreement and perfection of Assignee's interest in and to the Assigned Patents.

4. Terms of the Agreement. Nothing contained in this Patent Assignment is intended to or shall be deemed to modify, alter, amend, expand upon or otherwise change any of the rights, remedies, or obligations of Assignor and Assignee under the Agreement. In the event of any conflict or inconsistency between the terms of the Agreement and the terms hereof, the terms of the Agreement shall govern.

5. Governing Law; Jurisdiction. The provisions of Section 13 (*Governing Law*) and Section 14 (*Legal Proceedings*) of the Agreement shall apply to this Patent Assignment.

6. DISCLAIMER; LIMITATION OF LIABILITY. NOTWITHSTANDING ANYTHING IN THIS PATENT ASSIGNMENT OR THE AGREEMENT TO THE CONTRARY, THE ASSIGNED PATENT IS ASSIGNED AND ASSUMED ON AN "AS IS" BASIS WITH NO REPRESENTATIONS OR WARRANTIES, AND ASSIGNOR HEREBY EXCLUDES AND DISCLAIMS ANY EXPRESS OR IMPLIED REPRESENTATIONS OR WARRANTIES OF ANY KIND WITH RESPECT TO THE ASSIGNED PATENT, INCLUDING THOSE REGARDING MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT AND ANY WARRANTIES IMPLIED BY ANY COURSE OF DEALING OR TRADE USAGE. ASSIGNOR SHALL NOT BE LIABLE UNDER ANY LEGAL OR EQUITABLE THEORY FOR ANY DIRECT, INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL, PUNITIVE OR EXEMPLARY DAMAGES OF ANY KIND IN CONNECTION WITH THIS PATENT ASSIGNMENT EVEN IF ASSIGNEE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.


7. Counterparts and Execution. This Patent Assignment may be executed in two or more counterparts (including by facsimile, PDF or similar electronic means), all of which shall be considered one and the same agreement and shall become effective when one or more counterparts have been signed by each of the Parties and delivered to the other Party.

8. Successors and Assigns. This Patent Assignment shall be binding upon and shall inure to the benefit of the parties hereto their respective successors and assigns.

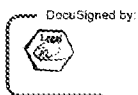


