TERMINATION OF SECURITY INTEREST IN TRADEMARKS AND PATENTS

This TERMINATION OF SECURITY INTEREST IN TRADEMARKS AND PATENTS (this “*Termination*”) is made by Fifth Third Bank, successor in interests to MB Financial Bank, N.A., with its principal place of business at 6111 N. River Road, 3rd Floor, Rosemont, Illinois 60018, (“*Secured Party*”), in favor of Block and Company, Inc., a Illinois corporation with its principal place of business at 1111 Wheeling, Illinois 60090 (“*Grantor*”). Unless otherwise defined herein or the context otherwise requires, terms used in this Termination shall have the meanings assigned to such terms in the Security Agreement (as defined below). Notwithstanding the foregoing, for the purposes of this Termination, “Marks” means those trademark registrations and trademark applications listed on Exhibit A attached hereto, and “Patents” means those patents and patent applications listed on Exhibit B attached hereto.

WHEREAS, the Grantor entered into that certain Grant of Security Interest in Trademarks and Patents, dated as of July 14, 2017 (the “*Security Agreement*”), between the Grantor and the Secured Party, a true and correct copy of which was recorded by the United States Patent and Trademark Office on August 16, 2018 at Reel 006415 Frame 0514 (Exhibit A) and on October 17, 2018 at Reel 047199 Frame 0771 (Exhibit B);

WHEREAS, the Secured Party desires (i) to release its security interest in the Marks, the Patents, all Proceeds, all of the goodwill of the businesses with which the Marks are associated, and all causes of action, past, present and future, for infringement, misappropriation, or dilution of any of the Marks and/or Patents or unfair competition regarding the same (collectively, the “*IP Collateral*”) and (ii) to terminate the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Secured Party hereby:


1. irrevocably terminates the Security Agreement;
2. irrevocably terminates, releases, and fully discharges any and all of its liens and security interests in all of the Grantors’ right, title and interest in, to, and under the IP Collateral, and reassigns, grants, and conveys to the Grantor all right, title and interest of Secured Party in and to the IP Collateral, without recourse or representation or warranty, express or implied; and
3. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given, and agrees to—at the Grantor’s cost and expense—duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably requested in writing by the Grantor to effectuate the release of its security interest contemplated hereby.

GRANT OF SECURITY INTEREST IN TRADEMARKS AND PATENTS

WHEREAS, Block and Company, Inc., an Illinois corporation (“**Grantor**”), owns the trademarks, trademark registrations, trademark applications, and any and all goodwill associated therewith, and the patents and patent applications, in each case set forth on Schedule A and Schedule B attached hereto; and

WHEREAS, MB Financial Bank, N.A. (the “**Grantee**”), desires to acquire a security interest in, and lien on, all of Grantor’s right, title and interest in and to Grantor’s trademarks, trademark registrations, trademark applications and any and all goodwill associated therewith and patents and patent applications; and

WHEREAS, the Grantor is willing to grant to the Grantee a security interest in and lien upon the trademarks, trademark registrations, trademark applications and any and all goodwill associated therewith and patents and patent applications described above.

This GRANT OF SECURITY INTEREST is made to secure the satisfactory performance and payment of all the Obligations (as such term is defined in the Credit Agreement) of the Grantor and shall be effective as of the date of the Credit Agreement.



This GRANT OF SECURITY INTEREST is made to secure the satisfactory performance and payment of all the Obligations (as such term is defined in the Credit Agreement) of the Grantor and shall be effective as of the date of the Credit Agreement.


