**CERTIFICATE OF AMENDMENT OF THE
SEVENTH AMENDED AND RESTATED CERTIFICATE OF INCORPORATION OF
CROWDFLOWER, INC.**

CrowdFlower, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the "General Corporation Law"),

DOES HEREBY CERTIFY:

FIRST: That the name of this Corporation is CrowdFlower, Inc.

SECOND: The Certificate of Incorporation of this corporation was originally filed with the Secretary of State of Delaware on December 21, 2007 under the name Dolores Labs, Inc.

THIRD: That by unanimous written consent, the Board of Directors of the Corporation adopted resolutions setting forth a proposed amendment to the Certificate of Incorporation of the Corporation, declaring said amendment to be advisable and in the best interests of the Corporation, which resolution setting forth the proposed amendment is substantially as follows:

NOW, THEREFORE, BE IT RESOLVED, that Article I of the Seventh Amended and Restated Certificate of Incorporation of the Corporation be amended to read in its entirety as follows:

"The name of this corporation is Figure Eight Technologies, Inc. (the "Corporation")."

FOURTH: That thereafter said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law.
