agreement including the Paris Convention (as amended) from any patent

- (d) the Patent Applications together with:
 - (i) any patent that may be granted pursuant to any Patent
Application; and
 - (ii) any future patent(s) and patent application(s) that are based on or
derive priority from or have equivalent claims to any Patent
Application in any country in the world (including divisionals,
continuations, continuations in part, supplementary protection
certificates, reissues, extensions, innovation patents and petty
patents).
- (e) any rights to sue for infringement of any of the rights described in
paragraphs (a) – (d) above.

3. ASSIGNMENT

3.2 **Second assignment:** Following the assignment in clause 3.1, in consideration of the sum of AU\$1.00 paid by the Assignee to Imdex Limited and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Imdex Limited, Imdex Limited hereby assigns to the Assignee absolutely all of its rights, title and interest in and to:

- (a) the Invention; and
- (b) the Intellectual Property Rights,

to the extent that Imdex Limited holds any such rights, title and interest immediately following the assignment in clause 2.1.

3.3 **Third assignment:** In consideration of the sum of AU\$1.00 paid by Assignee to the Second Inventor and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Second Inventor, the Second Inventor hereby assigns to Assignee absolutely all of their rights, title and interest in and to:

- (a) the Invention; and
- (b) the Intellectual Property Rights,

to the extent that the Second inventor holds any such rights, title and interest as at the date of this deed.

3.4 **Rights of action:** The assignments effected by clauses 3.1 to 3.3 include, without limitation, the assignment and transfer of all rights of action, powers and benefits arising from the ownership of the Intellectual Property Rights including, without limitation, the right to sue for damages and other legal and equitable remedies in respect of all causes of action arising before, on or after the date of this deed.

3.5 **Moral rights:** The Inventors waive all of their moral rights relating to Copyright works throughout the world, to the extent that they may lawfully do so.


5.2 **Counterparts:**
