**FIRST AMENDMENT
to the
INDIA RESEARCH LABORATORY AGREEMENT DATED JUNE 15TH 2007
between**

**INTERNATIONAL BUSINESS MACHINES CORPORATION ("IBM")
and
IBM INDIA PRIVATE LIMITED ("IBM INDIA")**

This first Amendment ("First Amendment") to the India Research Laboratory Agreement Dated June 15th, 2007 ("Agreement") between:

International Business Machines Corporation ("IBM"), a corporation organized and existing under the laws of the State of New York,

and

IBM India Private Limited ("IBM India"), a corporation organized and existing under the laws of [India]

is executed as of the date signed below. Capitalized terms not defined in this First Amendment shall have the meanings set forth in the Agreement.

IBM and IBM India agree as follows:

1. Amendment to Section 6.1. The first sentence of Section 6.1 is modified to read as follows:

"IBM India agrees that all ideas, techniques, inventions, designs of useful articles (whether ornamental or otherwise), systems, methods, formulas, discoveries, technical and other information, writings, drawings, artistic and literary works including computer programs, prototypes and other apparatus, and similar developments ("Developments") made or conceived, developed, created, discovered, written or obtained by IBM India, its employees, or third parties under subcontract with IBM India, in the course of or as the direct or indirect result of any project covered by overall project statements, and all patents, copyrights and/or other forms of protection for such Developments, will be the property of IBM and hereby assigns the same to IBM."



2. Amendment to Section 17. The first phrase of the first sentence in Section 17 is modified to read as follows:

"This Agreement and the First Amendment is the sole agreement between the parties on its subject matter and supersedes all prior understanding or agreements,"

IN WITNESS WHEREOF, IBM and IBM India have caused this first Amendment to the Agreement to be executed by their duly authorized representatives.


