
FIRST LIEN IP SUPPLEMENT NO. 1

This **FIRST LIEN IP SUPPLEMENT NO. 1**, dated as of May 31, 2022, is delivered pursuant to and supplements the First Lien Security Agreement, dated as of August 31, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "**Security Agreement**"), by and among the grantors named therein and **BARCLAYS BANK PLC**, as the Collateral Agent and is made by GoTo Group, Inc. (f/k/a LogMeIn, Inc.) (the "**Grantor**"). Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the Security Agreement.

The Grantor grants and pledges to the Collateral Agent (for the benefit of the Secured Parties) a security interest in all of the Grantor's right, title and interest in and to the Trademark Registrations, Issued Patents and Copyright Registrations and applications therefor and exclusive licenses in respect of any copyright registrations and applications therefor set forth on Schedule A annexed hereto. All such Intellectual Property shall be deemed to be part of the Intellectual Property Collateral and shall be hereafter subject to each of the terms and conditions of the Security Agreement.
