And I hereby authorize and request the Commissioner of Patents and Trademarks and other authorities in foreign countries to issue any and all patents on said Inventions or resulting from said Applications to **SWM International, LLC**, as assignee of my entire interest, and hereby covenant that I have the full right to convey the entire interest herein assigned, and that I have not executed and will not execute any agreement in conflict herewith.

And I further hereby covenant and agree that I will, at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title of said Inventions, Applications and patents as may be granted therefor, to **SWM International, LLC**, its successors, assigns, or other legal representatives and that if **SWM International, LLC**, its successors, assigns or other legal representatives shall desire to secure a reissue of any such patents or file any divisional, continuation, continuation-in-part applications or other patent applications relating to the Inventions or Application, or to file any disclaimers relating thereto, I will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite for the

filing of the same and the procuring thereof, without further compensation but at the expense of said assignee, its successors or other legal representatives.

And I do further covenant and agree that I will, at any time upon request, communicate to SWM International, LLC, its successors, assigns or other legal representatives, such facts relating to said Inventions, Applications and patents or the file histories thereof as may be known to me, and testify as to the same in any IPR or other administrative proceeding or litigation when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.
