**RELEASE OF SECURITY INTEREST IN PATENTS**

THIS RELEASE OF SECURITY INTEREST IN PATENTS, dated as of July 8, 2022, (this “Release”) is made by BARCLAYS BANK PLC, as Collateral Agent (the “Collateral Agent”) under the Grant of Security Interest in Patents (as amended, supplemented or modified and in effect from time to time, the “Security Agreement”), between THE CARLSTAR GROUP LLC, a Delaware limited liability company and MARASTAR, LLC a Delaware limited liability company, (each a “Grantor” and collectively the “Grantors”) and the Collateral Agent. Capitalized terms used but not defined herein have the meanings provided in the Security Agreement.

WHEREAS, pursuant to the Security Agreement dated May 30, 2019, the Grantors each granted to the Collateral Agent a continuing security interest in each Grantor’s right, title and interest in Patents, including those set forth on the attached Schedule I.

WHEREAS, Grantors have requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Patent Collateral (the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Collateral Agent in the Released Collateral, and (d) reassigns, grants and conveys to each Grantor any and all right, title and interest each Grantor has in the Released Collateral.
