For the same consideration, **Assignor**, by these presents does sell, assign and transfer to **GRAPHIC PACKAGING INTERNATIONAL, LLC** the full, exclusive and entire right, title and interest: in and to any and all applications for industrial property protection, including without limitation, all applications for patents, utility models, inventors’ certificates and designs, (the “Foreign Applications”) filed or which are hereafter filed in countries foreign to the United States and describing in whole or in part the said inventions and improvements, in and to any Patents and similar protective rights

granted on said Foreign Applications, and in and to the right to file such applications and the right to claim any applicable priority rights arising from or required for said Foreign Applications under the terms of any applicable conventions, treaties, statutes, or regulations; said Foreign Applications to be filed and issued in the name of **GRAPHIC PACKAGING INTERNATIONAL, LLC** or its respective designees, insofar as permitted by applicable law;


