RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST, effective as of May __, 2022, is made by COMERICA BANK pursuant to the Security Agreement defined below (in such capacity, "Bank").

WHEREAS, TIMBER AUTOMATION, LLC, a Delaware limited liability company, BAXLEY-LOGPRO INTERNATIONAL, INC., a Georgia corporation, PRICE LOGPRO, LLC, an Arkansas limited liability company, and BAXLEY EQUIPMENT COMPANY, LLC, a Georgia limited liability company (individually and collectively, "Grantor") executed and delivered an Intellectual Property Security Agreement dated as of August 31, 2015, in favor of Bank (as the same has been amended, restated or modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Grantor granted and pledged to Bank a security interest in and to Grantor's right, title and interest in, to, and under the Collateral (as defined in the Security Agreement), including without limitation the Patents and Trademarks (as each is defined in the Security Agreement; and collectively, "Intellectual Property Collateral") as set forth on the attached Exhibit A, Exhibit B, Exhibit C and Exhibit D, including without limitation all present and future rights (including, without limitation, the right to sue for past, present, or future infringements), titles, and interests of Grantor in and to all Intellectual Property applications, rights or licenses to use any trademarks, patents, copyrights, and all registrations and recordings thereof, including, without limitation, the Intellectual Property Collateral listed on Exhibit A, Exhibit B, Exhibit C and Exhibit D, and the goodwill of each business to which the Intellectual Property Collateral relates;

WHEREAS, the Security Agreement was executed on August 31, 2015, and recorded with the United States Patent and Trademark Office at Patent Reel/Frame 036481/0523 on September 2, 2015.

WHEREAS, the Bank no longer claims an interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, Bank hereby (i) terminates, discharges, releases and reassigns to Grantor the security interest in its entirety in, to and under the Collateral, including without limitation the Collateral identified on Exhibit A, Exhibit B, Exhibit C and Exhibit D; and (ii) waives any and all claims or interest Bank has or might have with respect to the Collateral pursuant to the Security Agreement; and

Bank agrees, at the Grantor's expense, to take all further actions, and provide to the Grantor and their successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and their successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
