**CERTIFICATE OF AMENDMENT

General Corporation Law of the State of Delaware

SafeShare, Inc. (hereinafter called the “**Corporation**”), a corporation organized and existing under the General Corporation Law of the State of Delaware, does hereby certify as follows:


1. The Board of Directors of the Corporation duly adopted a resolution, pursuant to Section 242 of the General Corporation Law of the State of Delaware, setting forth an amendment (the “**Certificate of Amendment**”) to the Amended and Restated Certificate of Incorporation of the Corporation (the “**Certificate of Incorporation**”) and declaring said amendment to be advisable. The resolution setting forth the amendment is as follows:

RESOLVED: That Article FIRST of the Certificate of Incorporation of the Corporation be and hereby is deleted in its entirety and the following is inserted in lieu thereof:

“**FIRST:** The name of this corporation is: SafeLiShare, Inc. (the “**Corporation**”).”
