**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of July 1, 2022 by **SILICON VALLEY BANK** a California corporation, with a loan production office located at 2100 North Greenville Ave, Suite 300, Richardson, Texas 75082, in its capacity as administrative agent and collateral agent for the Lenders (as defined in that certain Loan and Security Agreement among Grantor, Agent and the Lenders dated as of October 18, 2021) (in such capacity, "**Agent**"), in favor of **CYSIV, INC.**, a Delaware corporation (the "**Grantor**").

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement, dated as of October 18, 2021 (the "**Agreement**"), granting to the Bank a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Patents (as defined in the Agreement), notice of which was recorded with the United States Patent and Trademark Office ("**USPTO**") on October 19, 2021 at Reel 057831, Frame 0404.

WHEREAS, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Patents as herein provided; and

WHEREAS, Grantor has requested that the Bank provide a document suitable for recording with the USPTO to evidence the release of the Bank's security interests in and liens on the Patents as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests thereunder in Grantor's right, title and interest in, to and under the Patents, including, without limitation, those Patents and Patents applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
