
DECLARATION FOR CHANGE OF APPLICANT NAME

1. I am the inventor of U.S. Application No. 17/095,430 filed on November 11, 2020 (the "Application").
2. CAAMTECH LLC was erroneously named as the Applicant and, instead, should have been filed in the name of CAAMTECH, INC.
3. The naming of CAAMTECH LLC as the Applicant was in error due to inadvertence or mistake and was not for the purpose of delay or with the intention to mislead.
4. CAAMTECH, INC. is the true owner of the Application.
