Moon-Eagle Merger Sub II, LLC, a Delaware limited liability company ("**Second Merger Sub**"), which desires to merge with E\*TRADE Financial Corporation, a Delaware corporation (the "**Corporation**," and, together with Second Merger Sub, the "**Constituent Companies**"), hereby certifies that:

FIRST: The name and state of formation or incorporation, as applicable, of each of the Constituent Companies to the merger are as follows:

SECOND: The Agreement and Plan of Merger (the "**Merger Agreement**"), dated as of February 20, 2020, by and among the Corporation, Morgan Stanley, a Delaware corporation, and Moon-Eagle Merger Sub, Inc., a Delaware corporation, has been approved, adopted, certified, executed and acknowledged by each of the Constituent Companies in accordance with Sections 18-204 and 18-209 of the Delaware Limited Liability Company Act, in the case of Second Merger Sub, and Sections 103 and 264 of the Delaware General Corporation Law, in the case of the Corporation.

THIRD: Second Merger Sub shall be the surviving entity of the merger, and the certificate of formation of the surviving company shall be amended such that the name of the surviving company is changed to "E\*TRADE Financial, LLC".

FOURTH: The merger shall be effective as of the time of the filing of this Certificate of Merger with the Secretary of State of the State of Delaware (the “**Effective Time**”).

FIFTH: The executed Merger Agreement is on file at the place of business of Second Merger Sub at 1585 Broadway, New York, New York 10036.

SIXTH: A copy of the Merger Agreement will be furnished by the surviving company, on request and without cost, to any stockholder of the Corporation or member of Second Merger Sub.
