
AND WHEREAS, at the time the improvements were made, I was under an obligation to assign all of my right, title, and interest in said improvements to **MOOG INC.**

And I hereby authorize and request the Commissioner of Patents and Trademarks to issue said Letters Patent to said **MOOG INC.** as the assignee of my whole right, title, and interest thereto.

And I further agree to sign and properly execute such necessary and lawful papers for application for foreign patents, for filing subdivisions of said applications for patent, and for obtaining any reissue or reissues of any Letters Patent which may be granted for my aforesaid improvements, as the assignee thereof shall hereafter require and prepare at its own expense.
