ASSIGNMENT

WHEREAS, Whirlpool Corporation, a corporation formed under the laws of Delaware, having its main office at 2000 North M-63, Benton Harbor, Michigan 49022-2692, United States (hereinafter referred to as Whirlpool), and Panasonic Holdings Corporation, a corporation formed under the laws of Japan, having its main office at 1006 Oaza Kadoma, Kadoma-shi, Osaka 571-8501 Japan, (hereinafter referred to as Panasonic) jointly own U.S. Patent Application No. 16/309,214.

WHEREAS, Whirlpool is desirous of acquiring Panasonic's undivided share of the exclusive right, title, and interest in and to a divisional application to be filed claiming priority of U.S. Patent Application No. 16/309,214, pursuant to the Joint Development Agreement entered between the parties on June 27, 2014.

NOW, THEREFORE, in consideration set forth in the Joint Development Agreement, Panasonic hereby sells, assigns and transfers unto Whirlpool, Panasonic's undivided share of the exclusive right, title and interest in and to the divisional application to be filed claiming priority to U.S. Patent Application No. 16/309,214, including the right to claim priority thereto, the right to sue for past infringement, the share hereby assigned being such as to make Whirlpool the sole owner of the entire exclusive right, title and interest in and to the divisional application to be filed claiming priority to U.S. Patent Application No. 16/309,214.

For the avoidance of doubt, Whirlpool Corporation and Panasonic Corporation are, and shall remain, joint owners of U.S. Patent Application No. 16/309,214.
