PATENT RIGHTS ASSIGNMENT

The assignments of the Inventions and Patent Rights hereunder (and any assignment of related foreign patents or patent rights) constitute contributions to the capital of Assignee

pursuant to Section 351 of the Internal Revenue Code of 1986, as amended.

Assignor does hereby authorize the Director of the United States Patent & Trademark Office and the empowered officials of all other governments, whose duty it is to record patents, applications and title thereto, to record the Patent Rights and title thereto as the property of Assignee, its successors, or assigns in accordance with the terms of this instrument.

Assignor does hereby further authorize and request the Director of the United States Patent & Trademark Office and the empowered officials of all other governments to issue such Patent Rights or patents as granted upon the Patent Rights, or applications based thereon, to Assignee, its successors, or assigns.


The Assignor shall take such steps and actions, and provide such cooperation and assistance to the Assignee and its successors, assigns, and legal representatives, in connection with the Inventions and the Patent Rights, or for any inventions and discoveries derived therefrom, as may be necessary to effect, evidence, or perfect the Assignment to the Assignee or any assignee or successor thereto, including, but not limited to: the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney; the execution and delivery of all papers necessary in connection with any administrative or judicial proceedings; and the provision of information and testimony and cooperation in every way in obtaining and producing evidence and prosecuting such proceedings.

This Assignment inures to the benefit of the Assignee and its successors, assigns, and other legal representatives.

Assignee and Assignor also agree that multiple copies of this Assignment may be executed, each of which shall be deemed an original and each of which shall be valid and binding upon Assignee and Assignor and their respective legal representatives, successors and permitted assigns.


