RELEASE OF SECURITY INTEREST IN PATENTS

This **RELEASE OF SECURITY INTEREST IN PATENTS** (this “**Release**”) is made as of May 26, 2022, by **GOLDMAN SACHS SPECIALTY LENDING GROUP, L.P.**, in its capacity as collateral agent under the security agreements referred to below (“**Collateral Agent**”), in favor of **CURATION FOODS, INC.**, a Delaware corporation and **LANDEC CORPORATION**, a Delaware corporation (each, a “**Grantor**”).

WHEREAS, reference is hereby made to (a) that certain Pledge and Security Agreement (as supplemented or otherwise modified from time to time), dated as of December 31, 2020, executed by each Grantor in favor of Collateral Agent, and (b) that certain Patent Security Agreement (as supplemented or otherwise modified from time to time), dated as of December 31, 2020, executed by each Grantor in favor of Collateral Agent, and recorded in the records of the United States Patent and Trademark Office on April 23, 2021 at Reel/Frame 056020/0160; and


WHEREAS, pursuant to the above-referenced security agreements, each Grantor granted to Collateral Agent a security interest in and continuing lien on all of such Grantor’s right, title and interest in, to and under those patents set forth on Schedule A hereto (collectively, the “**Patent Collateral**”).

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Collateral Agent hereby (i) terminates and releases all security interests and continuing liens granted by each Grantor in favor of Collateral Agent in the Patent Collateral; (ii) assigns, transfers and delivers to such Grantor all of its right, title and interest in and to the Patent Collateral to the extent that any such right, title and interest exists as of the date hereof; (iii) authorizes such Grantor or its designee to make filings with the United States Patent and Trademark Office and to take further actions necessary to evidence the release and termination of Collateral Agent’s security interests in and liens on the Patent Collateral; and (iv) authorizes the governing body of the United States Patent and Trademark Office to record this Release.
