3. Request the Director of the United States Patent and Trademark Office to issue the Letters Patent to the Assignee;
4. Authorize and request Assignee and its attorneys to insert on this Assignment any further identification information, including an application number and filing date of the inventions and applications conveyed, transferred, and assigned in paragraph 1, *supra*, which may be necessary or desirable to identify such inventions and applications, and to correct any errors in the patent/application identification information provided above, whether discovered prior to or after recordation;
